Caution! A note about "Mandatory Training" for Umoja Users

We have seen a few emails disseminated to some departments which include a section on "mandatory training" for all staff members.

We would like to caution against sending a confusing message to the staff-at-large about Umoja training requirements.

At the moment, **there is no mandatory training for non-transactional users of Umoja** (staff members not mapped to an enterprise role).

Most staff will only be using Employee Self-Service and Manager Self-Service (ESS/MSS).

They do not need to learn about master data, the coding block, or the ECC environment. More than that, they may be confused and intimidated by the amount of information available in the Computer-Based Trainings on inspira.

ESS/MSS simulations on the Umoja website

Rather than asking them to complete CBTs on inspira, we recommend that you encourage your staff to take the ESS/MSS simulations on the Umoja website.

These simulations are much more user-friendly and they will be more effective in getting your staff ready for 1 November.

Please also encourage your staff to take part in the ESS/MSS Kiosk Demonstrations, where they can ask their own questions.

We understand that some of you may prefer to be able to track completion from your staff, which can be done with inspira CBT courses but not with the simulations.
